A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, OPPOSING THE KROGER - ALBERTSONS MERGER

WHEREAS, Kroger and Albertsons, two large grocery store corporations, have announced an intent to merge; and

WHEREAS, Safeway is a grocery market chain, and subsidiary owned by Albertsons which could be negatively impacted by the merger; and

WHEREAS, QFC is a grocery market chain, and a subsidiary owned by Kroger which could be negatively impacted by the merger; and

WHEREAS, the consolidation of these corporations would eliminate competition between Redmond's largest grocers and negatively impact grocery budgets for Redmond residents; and

WHEREAS, Redmond's grocery stores are cornerstones of the local community and one of the city's large employers, particularly union jobs; and

WHEREAS, earlier this month Kroger and Albertsons released a list of grocery store locations they intend to sell as part of the merger; and

WHEREAS, Washington has more grocery stores to be sold than any other state - 124 in total, including two QFCs and a Safeway in the City of Redmond; and
