Councilmember Margeson stated that the grants for the recycling events are on the May 7, 2019, regular business meeting agenda for approval, and the recycling events are continuing.

Public Safety Committee of the Whole

Eastside Transportation Partnership (ETP)

Councilmember Fields reported that the meeting was held on Friday and there were presentations from the Port of Seattle regarding airport transportation and Metro service on the eastside.

Sound Cities Association Public Issues Committee (PIC)

Councilmember Margeson reported that the pre-PIC workshop had a presentation from Metro regarding the transportation framework and mobility options, social equity and sustainability, and future funding needs.

Councilmember Margeson also reported on items discussed during the PIC meeting: legislative session recap; condo liability legislation; basic law enforcement academy funding; middle income housing challenges; taking a position I-976; King Conservation District proposed work plan and budget; and the parks levy.

Washington State Public Works Board

Councilmember Anderson stated that she was appointed by the Governor to serve on this committee and reported regarding the public assistance account; funding infrastructure; overcommitting funds; and reporting out after the state budget is passed.
