1. Approval of a Contract Amendment with MENG Analysis, in the Amount of \$100,000, for the Facilities Condition Assessment and Decarbonization Strategy

Department: Parks/Executive Action: Consent, March 5th

Loreen Hamilton, Parks and Recreation Director, and Jenny Lybeck, Sustainability Program Manager, reported to the Members of the Committee:

- Add \$100,000 to the agreement with MENG;
- Feasibility study; and
- Grant funded.

Discussion ensued regarding: site selection; how the information will be used; budgeting process; and sustainability.

2. Approval of Instructional Services Agreements: Snapology, Trackers, Nature Vision, TOPS, Eastside Skills Samurai, i9 Sports, and Skyhawks

Loreen Hamilton, Parks and Recreation Director, and Jeff Hagen, Recreation Supervisor, reported to the Members of the Committee:

- Reached the \$75,000 maximum;
- All seven agreements are increasing the maximum amount;
- Threshold was set in 2012;
- Recreation Activity Fund; and
- Serving more clients and increasing funds.

Discussion ensued regarding: cost recovery; camps; using the Redmond Senior and Community Center; variety of programs; evaluating programs; and public outreach.

## 3. Approval of Consultant Agreement with Claris Strategy, in the Amount of \$199,692, for the Building Security Strategic Plan

Department: Parks and Recreation

Action: Consent, March 5th

Loreen Hamilton, Parks and Recreation Director, and David Tuchek, Parks and Recreation Deputy Director, reported to the Members of the Committee:

- Development of the building security strategic plan;
- Security assessment report;
- City owned buildings and facilities; and
- Timeline.

Discussion ensued regarding: accounting of the studies that have been funded; using a California firm; need for a consistent and reliable system; security needs at the MOC; have not worked with the company before; and first time approaching this process.

#### 4. Tree Health Assessment and Mitigation Project Update

Department: Parks and Recreation Action: Study Session, March 12th

Loreen Hamilton, Parks and Recreation Director, and David Tuchek, Parks and Recreation Deputy Director, reported to the Members of the Committee:

- Comprehensive health and risk assessment on city-owned parcels;
- Mitigation plan was developed;
- Approximately 18,000 trees; and
- Identified trees that need mitigation.
