### Automated Speed Safety Cameras, Amended City Ordinance, and Camera Vendor Service Agreement

Department: Police

Action: Study Session, TBD

Darrell Lowe, Police Chief, and Brian Coats, Deputy Police Chief, reported to the Members of the Committee: development with an automated speed camera program; adoption of an ordinance; and approval of a service agreement.

Discussion ensued regarding: results of community feedback survey; Marymoor Park entrance non-motorized vehicles; schedule a study session; timeline; contract effective date; sole-sourcing; evaluating community input; revenue must go to traffic safety initiatives; building trust with the community; and educating the community.

#### 2. FEMA Subrecipient Agreement with Seattle Fire

Adrian Sheppard, Fire Chief, and Caleb Freeman, Battalion Chief, reported to the Members of the Committee: grant from Seattle Fire for equipment.

# 3. Acceptance of a Grant in the Amount of \$400,000 from the Washington State Department of Transportation for the purchase of an Electric Fire Engine

Adrian Sheppard, Fire Chief, and Michael Despain, Deputy Fire Chief, reported to the Members of the Committee: reimbursement for some of the cost of the electric fire engine and no matching funds are required.

### 5. City Resolution to Renew King County Medic One/EMS Levy (2026-2031)

Adrian Sheppard, Fire Chief, and Amy Moorehead, Medical Services Administrator, reported to the Members of the Committee:

- Levy period expires at the end of this year;
- Eight month process to develop a plan;
- City approval required to go on the ballot;
- Focuses on medical emergencies;
- Outcomes;
- Tiered system;
- Equity;
- Partnerships;
- Funded by an EMS levy;
- Diverse and growing population;
- Cost to homeowners;
- Task force recommendations;
- Distribution of funds;
- Risk analysis; and
- Financial summary.
