A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, ADOPTING THE 2025-2030 ENVIRONMENTAL SUSTAINABILITY ACTION PLAN

WHEREAS, the City of Redmond is actively building the city of the future through investments in light rail, transit oriented development, affordable housing, and clean energy to create a lowcarbon, climate resilient community; and

WHEREAS, these efforts support a thriving Redmond by enhancing public health, improving transportation options, supporting local economic development, and creating vibrant public spaces that strengthen community connection; and

WHEREAS, in 2017 the City adopted Resolution No. 1476, affirming its commitment to reduce greenhouse gas emissions, increase renewable energy and energy efficiency, and address environmental equity across sectors; and

WHEREAS, in 2020, the Redmond City Council adopted a 30-year Environmental Sustainability Action Plan that collectively commit our city to achieve community-wide carbon neutrality by 2050; and

WHEREAS, the City of Redmond committed to updating the Environmental Sustainability Action Plan every five years in partnership with the community to reflect community needs and update actions to keep Redmond on track towards its goals; and

WHEREAS, in November 2025, the City of Redmond completed the 2025-2030 Environmental Sustainability Action Plan five-year update in partnership with community members, organizations, and local tribes to create a plan that will substantially reduce GHG emissions in pursuit of Redmond's 2050 target and meaningfully enhance community and natural system resilience to climate change while prioritizing equity throughout implementation; and

WHEREAS, the 2025 Environmental Sustainability Action Plan establishes "Five Big Moves" and associated strategies and actions to be implemented over the next five years to reduce emissions from buildings, transportation, and waste, while growing community and natural system resilience to climate hazards; and

WHEREAS, adoption of the 2025 Environmental Sustainability Action Plan reaffirms the City's commitment to bold climate action that algins with globe emission reduction targets while creating a healthier, more inclusive, and climate resilient Redmond.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:
