## CITY OF REDMOND ORDINANCE NO.

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE BENEFITS PROVIDED TO MEMBERS OF THE CITY COUNCIL; ESTABLISHING AN ANCILLARY EXPENSE STIPEND; AMENDING ORDINANCE NO. 1638; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, based upon a review of compensation paid to elected officials of comparable cities, the City Council and the City of Redmond have determined a change in premium warranted in the health benefits applicable to the City Council; and

WHEREAS, the City Council benefits will now include an ancillary expense stipend.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Health Benefits. Health benefit premiums change to the full-time rate for individual councilmembers. Health benefit premiums for council family members remain unchanged. This ordinance amends the benefits established by Ordinance No. 1638.

Section 2. Ancillary Expense Stipend. Councilmembers will now receive an ancillary expense stipend of \$300 month to cover miscellaneous councilmember expenses to be used at councilmember discretion.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 6. Effective date. This ordinance shall become effective five days after its publication, or publication of a summary thereof, in the city's official newspaper, or as otherwise provided by law.
