## TITLE:

Redmond Senior and Community Center Construction Contract Format

## **OVERVIEW STATEMENT**:

Staff is requesting input on, and approval of, the proposed Redmond Senior and Community Center construction contract format. To meet schedule deadlines, the construction contract will be divided into 3 separate Maximum Allowable Construction Costs (MACC) elements. Staff is proposing that the construction contract for MACC 1 include estimated amounts for MACCs 2 and 3 that can subsequently be executed by Mayor signature as long as the bids for MACCs 2 and 3 are below the estimated amounts approved with MACC 1.

The GC/CM construction contract we are using for this project is based on the University of Washington's GC/GM contract that has been used successfully on a number of projects and has been reviewed and edited by the City's construction attorney.

We expect the construction contract to go forward at the May 24, 2022, Parks and Environmental Services Committee of the Whole meeting and subsequently for approval at the June 7, 2022, business meeting so that we can issue a notice to proceed with construction by mid-June.
