

**CITY OF REDMOND**

AN ORDINANCE OF THE CITY OF REDMOND,  
WASHINGTON, AMENDING THE SALARY TO BE PAID  
TO THE MAYOR; MAINTAINING A CAR ALLOWANCE;  
AND AMENDING ORDINANCE NO. 2967; EFFECTIVE  
JANUARY 1, 2024

WHEREAS, the City Council and the City of Redmond have determined an increase is warranted in the salary to be paid the Mayor; and

WHEREAS, the City Council desires to maintain a car allowance paid to the Mayor for the use of the Mayor's personal vehicle on City business.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1.      Mayor's Salary. Effective January 1, 2024, the salary of the Mayor of Redmond shall be \$170,000 annually for 2024 and 2025, and effective January 1, 2026, will be increased to \$175,000 annually thereafter until updated by ordinance, payable in equal periodic installments according to the same pay schedule as other City employees. The next review of the Mayor's salary shall be in 2026 in preparation for the 2027-2028 budget. This ordinance amends the salary established by Ordinance No. 2967.

Section 2.      Car Allowance. The car allowance paid monthly to the Mayor shall remain at \$500 per month.

Section 3.      Severability.    If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4.      Effective date.    This ordinance shall take effect and be in full force January 1, 2024, which is more than five (5) days after its passage and publication, as provided by law.
