1. Proposed Fee Program for Extended Use of Right of Way

Department: Public Works

Action: Consent, September 3rd

Aaron Bert, Public Works Director, Vangie Garcia, Public Works Deputy Director, and Patty Criddle, Transportation Engineering Supervisor, reported to the Members of the Council regarding:

- Extended closure of the right-of-way for private businesses;
- Discourage long closures of the right-of-way;
- Fee structure;
- Increased demand for long term closure;
- Must pay state excise fee tax;
- Outdoor dining and construction activity;
- Fees in neighboring cities;
- Community outreach and involvement;
- Questionnaire responses; and
- Next steps.

Discussion ensued regarding: designated seating area; benchmarks; permit fee costs; current businesses with outdoor seating; safety concerns; fees for local businesses; year-round outdoor dining; maintenance; separating out the two types of fees; keeping sidewalks open during construction; lower fee options; and bringing the outdoor seating item to Committee of the Whole.

2. Safer Streets Action Plan Status Update

Department: Planning and Community Development

Action: Informational

Carol Helland, Director of Planning and Community Development, Michael Hintze, Transportation Planning Manager, Francesca Liburdy, Senior Transportation Planner, and Seraphie Allen, Deputy Director of Planning and Community Development, reported to the Members of the Council:

- Safety of transportation system;
- Federal and state grant money;
- 2050 transportation vision;
- Necessary to apply for more funding;
- Safe system approach;
