





Extended Use of Public Right of Way (ROW): Right of Way Use Fees

The City has allowed the closure of public Right of Way (ROW) for the benefit of private businesses without charging a use fee nor the excise tax on the value of the use fee that has been paid to the State. Private use of ROW limits public access and enjoyment of sidewalks, landscape, bike lanes, parking, and travel lanes. To balance the needs of private businesses with the needs of the public, the City will collect a ROW use fee and the State-required excise tax beginning January 2025 for extended public right of way closures.

The proposed use fees are based on research, align with surrounding agencies, and are right-sized for Redmond. The fee will be applied to closing any portion of the ROW for private use for periods over two weeks.

Outdoor dining and construction activities are common examples of extended ROW closures for private use.

For Outdoor Dining:

The annual fee for outdoor dining is charged to restaurants that are expanding their business into the public ROW.

Annual fee of \$2.00 per square foot of closed ROW for outdoor dining

For Construction Activity:

It is understood that private property development in urban centers may not have sufficient space for some construction activities and requires work zone expansion into the ROW. The monthly fee is intended to encourage the shortest closure duration to complete the necessary construction activity.

Monthly fee of \$0.75 per square foot of closed ROW for construction activity

In addition to collecting these use fees, the City must collect a leasehold excise tax to be remitted to Washington State per (RCW 82.29A.030). The leasehold excise tax is 12.84% of the use fee for the closed ROW.

OVERVIEW STATEMENT:

Safer Streets Action Plan Status Update

TITLE:

Redmond received United States Department of Transportation (USDOT) Safe Streets for All (SS4A) funding in conjunction with Puget Sound Regional Council (PSRC), through an agreement between the City and PSRC. With this funding, the City is developing a Safer Streets Action Plan. The SS4A funding can be applied to implementation, planning, and demonstration projects in line with USDOT's Safe System Approach. Establishing a Safer Streets Action Plan is necessary to apply for grant-funded projects. When finished, the Action Plan will develop and prioritize safety improvement projects throughout the City and facilitate upcoming applications for safety grant funding. This status update will provide an overview of the goals of the Safer Streets Action Plan, the anticipated timeline for the development of the plan, preliminary strategies that will be included in the plan, and upcoming milestones.

As shown above, engagement has included field visits led by Transportation Planning's consultant team to walk through the Education Hill neighborhood with staff and community members. The walk incorporated ideas about possible safety improvements in the area and facilitated discussion between staff from varying departments. Following the walk, a debrief workshop was held to review and develop possible improvements in Education Hill and beyond, looking closely at how staff can apply specific ideas on a broader citywide scale.

Additional field visits, workshops, and focused task force meetings will occur.

Feedback Summary:

Takeaways included safety concerns from local community members in the Education Hill neighborhood. Staff and the consultant team are incorporating these concerns when developing preliminary safety strategies that will be included in the Safer Streets Action Plan.







- Redmond Way/ELSP Intersection Improvements
 - o Re-aligned crosswalks and added bike lanes/signals/striping
- 40th Street Shared Use Path
 - o Shared Use Path from 156th Ave to 163rd Ave in front of Microsoft campus
- Rectangular Rapid Flashing Beacons Project
 - o (TOSE) Added RRFB's at 3 locations, 180th Ave/70th Street, 161st Ave/81st St, and 116th St/ 179th Ave
- 90th Street Preservation (incorporated bike safety improvements in overlay project)
 - o Added bike signals and striping as part of overlay project








Preliminary Preferred Option





Preliminary Preferred Option ROM Costs



Problem Statement

A clear and concise description of the issue(s) that need(s) to be addressed.

In October of 2022, Kroger and Albertson's – two major national corporations – announced their intent to merge. would lead to store closures, job losses, and higher prices, both in Redmond and across our state. The proposed merger would also impact producers, food processors and farmers here in Washington state and around the nation. Finally, the proposed merger would impact the ability of union grocery store workers to be able to negotiate for better wages and benefits because if the two largest traditional grocery store chains were to become one, then the leverage in negotiations would largely disappear.

Local union UFCW 3000 has helped create a national coalition of other unions and other organizations that has resulted in hundreds of TV, radio and newspaper stories, acted at stores across the country, met with state and federal regulators, and ultimately helped bring about the lawsuits filed by the Federal Trade Commission (FTC) and states attorneys general to oppose the proposed merger. These lawsuits are going to trial soon – the FTC case starts in federal court in Oregon in late August and the Washington State AG case begins here in our state in mid-September.

Proposal

What is being proposed to assist in addressing the issue described in the problem statement?

The Redmond City Council adopts a resolution to express its official position in opposition of the Kroger-Albertson's merger and sends a copy of this resolution to the Federal Trade Commission, asking them to oppose the merger.

Relationship to City Business or Proposed City Business/Services

Describe how this will enhance what is already offered and/or what it will provide that is not currently available. Why is this the City's issue to address? How will this create a more adaptive and resilient organization?

Earlier this month, Kroger and Albertson's released a list of grocery store locations which they intend to sell as part of the merger, and Washington has more grocery stores to be sold than any other state — 124 in total. This includes four in Redmond (the three (3) QFC's and the Safeway in Redmond:

- QFC 15800 Redmond Way, Redmond
- QFC 8867 161st Ave NE. Redmond
- QFC 23475 NE Novelty Hill Rd, Redmond
- Safeway 15000 NE 24th, Redmond

Passing a resolution opposing the merger will show solidarity with the many grocery store workers in Redmond and demonstrate our commitment to creating a more inclusive Redmond for all workers and residents.

RESOLUTION

WHEREAS, Kroger and Albertson's, two large grocery store corporations, have announced an intent to merge; and

WHEREAS, Safeway is a grocery market chain, and a subsidiary owned by Albertsons, which could be negatively impacted by the merger; and

WHEREAS, QFC is a grocery market chain, and a subsidiary owned by Kroger which could be negatively impacted the merger; and

WHEREAS, Redmond's grocery stores are a cornerstone of the local community, and one of the city's largest employers, particularly union jobs; and

WHEREAS, earlier this month, Kroger and Albertson's released a list of grocery store locations which they intend to sell as part of the merger; and

WHEREAS, Washington has more grocery stores to be sold than any other state — 124 in total, including the three (3) QFC's and the Safeway in Redmond; and

WHEREAS, ensuring a thriving local economy, job opportunities, and convenient shopping options for the community are priorities for the City of Redmond; and

WHEREAS, approval of this merger would almost certainly lead to store closures, could undermine thousands of unionized grocery jobs, would likely increase prices for consumers, and worsen food deserts.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The Redmond City Council adopts this resolution to express its official position in opposition of the Kroger-Albertson's merger.

Section 2. The Redmond City Council sends a copy of this resolution to the Federal Trade Commission, asking them to oppose the merger.
