Work Activities for the Reporting Period

- For the NE 40th St. Trunkline Extension Monitoring, the consultant calibrated the existing flow model based on Water Year 2024 data, produced the final report for Water Year 2024 and performed project management and team coordination. City staff reviewed and accepted the final report for Water Year 2024 and conducted project administration.

% Complete and Invoice for the Reporting Period

As of the latest invoice up to January 31, 2025

- The planned monitoring and reporting, as laid out in the project monitoring plan (QAAP), is 100% complete. The final report noted some minor scouring over the past two years where the outfall channel meets the lake. Based on recommendations from the consultant, the City has adjusted the trunkline flow splitter to the previous year's setting (sending less water to the trunkline) and plan to conduct another bathymetry survey of the lakeshore this summer to see if the scouring has continued or stopped. Based on that survey information the City will make further adjustments to the flow splitter if necessary.
