City of Redmond,

This letter is to provide you with 2022 detention rates, effective January 1, 2022, for housing your inmates in King County jail facilities. Rates were prepared pursuant to the Interlocal Agreement between the County and King County cities. Due to COVID-19 population restrictions, the Department of Adult and Juvenile Detention is only employing basic annual inflation in 2022, rather than implementing a full cost reset.

Rates effective January 1, 2022 through December 31, 2022

The Exhibit III Calculation of Fees, Charges and Surcharges, in the Interlocal Agreement specifies the fees, charges and surcharges as well as the Offsite Medical Charges, the City shall pay. Also, Exhibit III c., i., denotes that King County will increase the Maintenance charge to capture the cost of capital expenditures that benefit jail operations. In 2022, the debt service for the Courthouse Seismic Stabilization Project (CSSP) is \$0.93 and the debt service for the Integrated Security Project (ISP) is \$4.63. For the period of January 2022 through December 2022, the rates are as follows:
