HEARINGS AND REPORTS

STAFF REPORTS

a. AM No. 19-045: Amendments to the Redmond Zoning Code per Federal Communications Commission Ruling

Mr. Scott Reynolds and Ms. Kim Dietz of the Planning Department provided a report to the Mayor and Members of the Council regarding the proposed zoning code amendments, noting the action is necessary to stay in compliance with FCC regulations. The action is to support the implementation of 4 and 5G across the country. The matter is proposed for action on April 16, 2019.

Councilmember Myers opined that he would like more details regarding the size and weight of the antennas. Mayor Marchione noted that details were provided in the 2018 report and previously adopted 2018 policy.

Councilmember Fields spoke regarding safety and not having enough industry information to know whether or not there are any impacts in that regard.

OMBUDSPERSON REPORTS

Councilmember Birney stated that she received citizen contacts regarding:

- the city parking survey;
- comments on the Sammamish River Trail;
- a report of Redmond signs posted on the Bellevue side of the highway;
- reports of graffiti under the trail bridge;
- if bike and pedestrian service was available through city drive-throughs;
- business undertaken during the last Council meeting; and
- a potential bike share program in the City.

Councilmember Birney noted that all items have been addressed or are currently being followed up on by staff.

Councilmember Carson stated that he received an email from a business owner asking about expansion of their business. Councilmember Carson provided contact information of staff for the business owner to inquire with further.

Councilmember Fields reported that he attended the most recent People for Climate Action meeting. The group would like to see elected officials in the regional area work more closely together regarding regional efforts.

COMMITTEE REPORTS

Government Affairs Committee - OneRedmond

Councilmember Padhye advised the committee last received a presentation on workforce housing. She provided a list of questions to the Council that she would like them to consider as they prepare for the April 9, 2019, study session. She encourages this topic being part of the Council's strategic plan moving forward.

Parks and Human Services Committee of the Whole

Councilmember Myers overviewed topics discussed during the April 2, 2019, committee meeting.

Finance, Administration, and Communications Committee of the Whole

Councilmember Margeson provided the committee report from the March 26, 2019, meeting. He overviewed the Council LEAN projects discussed, as well as the Enterprise Content Management project update.

Regional Transit Committee (RTC)

Councilmember Margeson reported that he has been appointed the Vice-chair of the RTC. Different options for mobility and transitoriented development were discussed during the last meeting.

Regional Policy Committee (RPC)

Councilmember Birney reported that the parks levy process is in full swing and some amendments have been made by Council Members. She reported that the Solid Waste Comprehensive Plan was discussed, and also received amendments.

Miscellaneous

Councilmember Birney reported that the Cascade Water Alliance celebrated their $20^{\rm th}$ anniversary last week; and separately, she met this morning in a discussion on middle income housing. Regional developers expressed their willingness to assist with challenges.
