## REDMOND CITY COUNCIL ORDINANCE NO.

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE REDMOND 2050 COMPREHENSIVE PLAN BY ADOPTING THE 2025-2050 REDMOND FIRE FUNCTIONAL PLAN, PROVIDING FOR SEVERABILITY, AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the Growth Management Act (GMA) requires that comprehensive plans and development regulations shall be subject to continuing evaluation and review; and

WHEREAS, the City adopted the Redmond 2050 Comprehensive Plan under Ordinance 3181 in November 2024; and

WHEREAS, the City addresses certain GMA requirements for Comprehensive Plans in functional plans; and

WHEREAS, City capital facility planning policies require functional plans to have a planning horizon to 2050 to be consistent with the Redmond 2050 Comprehensive Plan; and

WHEREAS, the 2025-2050 Redmond Fire Functional Plan is intended to be adopted by reference into the Redmond Comprehensive Plan to fulfill GMA and City planning requirements for adequate public facilities and levels of service; and

WHEREAS, the purpose of the 2025-2050 Redmond Fire Functional Plan is to ensure the City's fire facilities and equipment can accommodate anticipated growth; and

WHEREAS, the purpose of updating the Comprehensive Plan is to extend the planning horizon from 2030 to 2050; to incorporate the themes of equity and inclusion, sustainability, and resilience; to reflect changes in the GMA, regional, and countywide planning documents since 2011; and to reflect City actions or studies since the 2011 Comprehensive Plan update; and

WHEREAS, on October 6, 2020, the City Council adopted Resolution No. 1538, which established the scope, timeline, and community involvement plan for Redmond 2050; and

WHEREAS, throughout Redmond 2050 the City executed a multifaceted community involvement program to engage Redmond's diverse community, using methods such as a digital city hall lobby, online questionnaires, virtual workshops, in-person workshops, social media, videos, yard signs, utility bill inserts, newsletters, focus groups, contracting with community-based organizations, office hours, tabling at community events, pop-up engagement around the city, translating materials, a community advisory committee, a technical advisory committee, and attending board and commission meetings; and

WHEREAS, on October 12, 2020, the City of Redmond issued determination of significance for Redmond 2050 under the State Environmental Policy Act; and

WHEREAS, state agencies were sent 60-day notices of Redmond's proposed 2025-2050 Redmond Fire Functional Plan on September 9, 2025; and

WHEREAS, from July 23, 2025 to August 27, 2025, the Planning Commission conducted study sessions and held a public hearing for the 2025-2050 Redmond Fire Functional Plan and subsequently transmitted a recommendation to the City Council for consideration; and

WHEREAS, from September 9, 2025 to November 18, 2025, the City Council received a staff report and held study sessions to study the Planning Commission's recommendation; and

WHEREAS, having considered the Planning Commission's recommendation and community input, the City Council desires to adopt the 2025-2050 Redmond Fire Functional Plan.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Classification. This is a non-code ordinance.

Section 2. Findings and Conclusions. The City Council hereby adopts the findings and conclusions contained in the associated Planning Commission Report, including all related attachments and exhibits, City file no. LAND-2025-00156.

Section 3. 2025-2050 Redmond Fire Functional Plan

Adopted. The 2025-2050 Redmond Fire Functional Plan is adopted to read as shown in Exhibit 1, attached hereto and incorporated herein by this reference as if set forth in full.

<u>Functional Plan Document.</u> The Administration is directed to complete preparation of the final 2025-2050 Redmond Fire Functional Plan, including updates to numbering, correction of any typographical errors, minor editorial revisions, inclusion of appropriate graphics and illustrations, and general formatting.

Section 5. Severability. If any section, sentence, clause, or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity of any other section, sentence, clause, or phrase of this ordinance.

Section 6. Effective date. This ordinance shall become effective five days after its publication, or publication of a summary thereof, in the City's official newspaper, or as otherwise provided by law.
