# **OVERVIEW STATEMENT:**

Requesting City Council approval on the revised opening date for the full-street closure of NE 60<sup>th</sup> Street related to the Sound Transit Downtown Redmond Link Extension (DRLE) project. NE 60<sup>th</sup> Street will be open to two-way traffic in September 2022 with a target of the week of September 19, 2022.

Traffic will be routed to a detour which includes NE 51<sup>st</sup> Street. This is the same detour that was used in Spring 2022.

A safe-route to Ben Rush Elementary will continue to be provided by the ADA compliant, temporary bridge to accommodate pedestrians and cyclists.

#### COMMUNITY/STAKEHOLDER OUTREACH AND INVOLVEMENT:

• Timeline (previous or planned):

Preliminary stakeholder outreach has been undertaken with the Lake Washington School District. Broad stakeholder outreach with detour and scheduling information began on August 10 following Council notification at the Finance, Administration, and Communication Committee of the Whole meeting on August 9, 2022.

• Outreach Methods and Results:

The City will work in partnership with Sound Transit to communicate broad information related to the closure. Sound Transit will share via social media, send a construction alert, post on their website, and update existing signage. Sound Transit will also work with the Lake Washington School District and the Ben Rush Elementary community to communicate impacts to affected families and staff. The city will amplify Sound Transit's messaging on city communication channels.
