CITY OF REDMOND ORDINANCE NO.

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING RMC 6.36.030, IDENTIFICATION OF NOISE ENVIRONMENTS AND MAXIMUM PERMISSIBLE NOISE LEVELS, IN ORDER TO ADD NEW ZONING DESIGNATIONS TO TABLE 1; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the City of Redmond will establish new zoning districts through the adoption of the Marymoor Subarea Comprehensive Plan and Zoning Code Amendments and Local Center Designation; and

WHEREAS, RMC 6.36.030, Identification of noise environments and maximum permissible noise levels, establishes noise limits for each zoning district in Redmond; and

WHEREAS, new zoning districts need to be added to Table 1 in RMC 6.36.030, Identification of noise environments and maximum permissible noise levels, to ensure that the table remains comprehensive;

WHEREAS, the additions to Table 1 are consistent with State requirements for maximum permissible noise levels (Chapter 70.107 RCW and Chapter 173-60 WAC).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

 $\underline{\text{Section 1}}$. $\underline{\text{Classification}}$. This ordinance is of a general and permanent nature and shall become a part of the City Code.

Section 2. Amendment of Section. RMC 6.36.030, Identification of noise environments and maximum permissible noise levels, is hereby amended to read as follows:

- (A) Environmental Designation for Noise Abatements (EDNA) are established based on consideration of historical, present and future land use of each zoning district.
- (B) No person shall cause or permit sound to intrude onto the real property of another person that exceeds the maximum permissible sound levels established by this chapter. The point of measurement shall be anywhere within the receiving property.
- (C) Maximum permissible noise levels are given below and are consistent with State requirements (Chapter 70.107 RCW and Chapter 173-60 WAC):
