a. AM No. 19-088: City of Redmond Community Strategic Plan

Ms. Maxine Whattam, Chief Operating Officer, provided a report to the Mayor and Council regarding the Council's Community Strategic Plan, and spoke regarding items such as a sustainable multi-housing program.

Councilmember Fields inquired regarding opportunity for environmental protection and the workplan for the new sustainability position at the City.

Ms. Whattam advised that the employee would be onboarded towards the end of fall and staff will be working to develop their workplan.

## Eastside Transportation Partnership (ETP)

Councilmember Carson advised that ETP meet last week and received a report from the WSDOT undersecretary; and separately, Metro Marine and Puget Sound Regional Council discussed water borne transportation and electric ferries.

## Regional Policy Committee (RPC)

Councilmember Birney spoke regarding the last RPC meeting held and robust discussion at that time regarding the requirements necessary for placement of the EMC levy renewal on the November ballot.

# King County Board of Health

Councilmember Anderson reported that the Board of Health received a briefing on the measles outbreak. Information is included on the King County Health Department's website.

# Sound Cities Association - Public Issues Committee (PIC)

Councilmember Margeson reported the PIC last met on May 8, 2019, beginning with a workshop on parliamentary procedure. Also discussed was: affordable housing and appointments to the board; a 2019 legislative session update; and the King Conservation District and proposed rate increases.
