A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE FIRE DEPARTMENT FEE SCHEDULE, ORIGINALLY ADOPTED BY RESOLUTION NO. 1073, AND AMENDED THROUGH RESOLUTION NO. 1281, 1389 AND 1452, IN ORDER TO PROVIDE FEES FOR PERMITS ASSOCIATED WITH ADOPTION OF THE 2018 REDMOND FIRE CODE

WHEREAS, Resolution No. 1073 of the City of Redmond adopted a schedule of fees, charges, and penalties related to the activities of the Redmond Fire Department; and

WHEREAS, the schedule adopted by Resolution No. 1073 has been previously amended through Resolution No. 1281, 1389 and 1452 in order to revise certain fee amounts and to establish other fees; and

WHEREAS, the 2018 International Fire Code had modified the list of required permits;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Fee schedule amended. The Fire Department fee schedule adopted by Resolution No. 1073, as previously amended, is hereby further amended to add the following fees:

A. <u>Cutting and welding.</u> The fee for operating a cutting and welding shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Cutting and welding

Permit Threshold: Operate or conduct

Fee: \$198.93*

B. <u>Fire hydrants and valves.</u> The fee for operating fire hydrants and valves shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Fire hydrants and valves

Permit Threshold: Permits issued by Planning Department,

Development Engineering Division

Fee: N/A

C. <u>Miscellaneous combustible storage</u>. The fee for miscellaneous combustible storage shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Miscellaneous combustible storage

Permit Threshold: Per location

Fee: \$149.20*

D. <u>Mobile food preparation vehicles</u>. The fee for mobile food preparation vehicles shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Mobile food preparation vehicles

Permit Threshold: Per vehicle

Fee: \$149.20*

E. Motor fuel dispensing facilities. The fee for motor fuel dispensing facilities shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Motor fuel dispensing facilities

Permit Threshold: Per facility

Fee: \$248.66*

F. Repair garages. The fee for repair garages shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Repair garages

Permit Threshold: Per location

Fee: \$248.66*

G. Rooftop heliports. The fee for rooftop heliports shall be added to fee schedule Table H1 as follows:

Fire Code Permit Type: Rooftop heliports

Permit Threshold: Per location

Fee: \$248.66*

H. <u>Exhibits and trade shows.</u> The fee for operating exhibits or trade shows shall be added to fee schedule Table H2 as follows:

Fire Code Permit Type: Exhibits or Trade shows

Permit Threshold: Each

Fee: \$289.39*

I. <u>Floor finishing</u>. The fee for floor finishing shall be added to fee schedule Table H2 as follows:

Fire Code Permit Type: Floor Finishing

Permit Threshold: Per site

Fee: \$149.20*

J. Open burning. The fee for open burning shall be added to fee schedule Table H2 as follows:

Fire Code Permit Type: Open burning

Permit Threshold: Per location

Fee: \$298.39*

K. <u>Outdoor assembly event.</u> The fee for outdoor assembly events shall be added to fee schedule Table H2 as follows:

Fire Code Permit Type: Outdoor assembly event

Permit Threshold: Per event

Fee: \$397.86*

L. <u>Capacitor energy storage systems</u>. The fee for capacitor energy storage systems shall be added to fee schedule Table I as follows:

Type of Installation: Capacitor energy storage systems

Quantity or Level Description: Per system

Fee: \$348.13

M. <u>Fuel cell power systems.</u> The fee for fuel cell power systems shall be added to fee schedule Table I as follows:

Type of Installation: Fuel cell power systems

Quantity or Level Description: Per system

Fee: \$348.13

N. <u>Gas detection systems.</u> The fee for gas detection systems shall be added to fee schedule Table I as follows:

Type of Installation: Gas detection systems

Quantity or Level Description: Per system

Fee: \$298.39

O. Motor vehicle repair rooms and booths. The fee for motor vehicle repair rooms and booths shall be added to fee schedule Table I as follows:

Type of Installation: Motor vehicle repair rooms and booths

Quantity or Level Description: Per room or booth

Fee: \$298.39

P. <u>Special event structure.</u> The fee for special event structure shall be added to fee schedule Table I as follows:

Type of Installation: Special event structure

Quantity or Level Description: Per structure

Fee: \$298.39

Section 2. Fee schedule amended. The Fire Department fee schedule adopted by Resolution No. 1073, as previously amended, is hereby further amended to delete the following fees:

- A. <u>Battery systems.</u> The fee for battery systems shall be deleted from fee schedule Table H1.
- B. <u>Carbon dioxide systems</u>. The fee for carbon dioxide systems shall be deleted from fee schedule Table H1.
- C. <u>Motor vehicle operations</u>. The fee for motor vehicle operations shall be deleted from fee schedule Table H1.
- <u>Section 3.</u> Fee schedule amended. The Fire Department fee schedule adopted by Resolution No. 1073, as previously amended, is hereby further amended to modify the following permits:
 - A. <u>Compressed gases.</u> Add carbon dioxide to the existing list of gasses in Table H1 for the permit Compressed Gasses (Inert, simple asphyxiant, oxidizing).
 - B. <u>Hot-work operations (welding & cutting)</u> Delete the term '(cutting & welding)' from the permit type Hot-work operations (cutting & welding) in table H1.
 - C. Marijuana extraction systems. Modify the term
 'marijuana' to 'plant' in the permit type Marijuana
 extraction systems in Table H1.

E. <u>Marijuana extraction systems.</u> Modify the term 'marijuana' to 'plant' in the permit type Marijuana extraction systems in Table I.

Section 4. Annual adjustment. The fees set forth in Section 1 are subject to the annual adjustment and review process and limitation provided in Sections 3, 4, and 5 of Resolution No. 1073.

Section 5. Effective date. The fees established by Section 1 shall become effective, with the addition of the 2021 CPI adjustment, upon February 1, 2021.
