

Summary of 2020 Updates to the Proposed 2021-2026 Six-Year Transportation Improvement Program (TIP)

A. Completed

These projects were removed from the TIP because they were completed in 2020.

- B40 – Overlake Village Pedestrian-Bicycle Bridge
- B49 – NE 80th St Trail Connection
- B53 – Redmond Central Connector Linkages (pedestrian crossing at 87th St across Willows Road, and pedestrian link from Red 160 alley to the Connector)
- B67 – 51st St Multimodal Improvements
- P19 – Avondale Rd Pavement Rehab – Novelty Hill Rd to NE 116th St
- P37 – 156th Corridor Temporary Paving
- P43 – Sidewalk Repairs
- S51 – ADA Ramp Improvements – Downtown
- S54 – 156th Ave NE Pedestrian Signal on 4700 Block

B. Removed

These projects were removed from the TIP because they are not included in the proposed Capital Investment Program (CIP).

- C82 – 160th Street Extension Design
- S60 – Willows Golf Course Mid-block Crossing
- T14 – Redmond Way and 132nd Westbound Queue Jump @ 132nd Ave

C. Added

These projects have been added to the TIP because they are included in the proposed CIP, the Proposed CIS, or are included in Development Agreements, Grants, or Partner Agency projects.

- The following projects are funded in the proposed CIP:
 - B99 – Redmond Central Connector Improvements – Design – Redmond Central Connector between 164th Ave and the Bear Creek Trail
 - C88 – Willows Road Improvements Phase 1 – Turn Lane and 2 Signals – Willows Road between the 9900 Block Signal and 124th Street
 - C89 – Plaza Street Connection - Overlake (Shen St to 152nd Ave)

- P100 – 10,000 Block of Avondale Road Erosion
- P101 – Retaining Walls - Replacement and Installation (Redmond Way @ Willows)
- P102 – Pavement Management - Avondale Rd (North of Union Hill to Novelty Hill Rd)
- P103 – Pavement Management – West Lake Sammamish Parkway (North of Marymoor to Leary Way)
- P104 – 2021-2022 Pavement Repair – Various locations, Citywide
- S71 – Targeted Safety Improvement Project (TSIP) - Rectangular Rapid Flash Beacon (RRFB) Crossing (180th Ave @ NE 70th St)
