Presiding Officer David Carson called the meeting to order, reviewed attendance, and overviewed the agenda.

Approval of a Contract with Perteet, Inc. in the Amount of \$360,453 to Design the Redmond Way (SR 202) and East Lake Sammamish Parkway (ELSP)/180th Avenue NE Intersection Improvements and Authorize Staff to Negotiate and Acquire Minor Property Rights as Needed for the Project

Mr. Eric Dawson, Senior Engineer, and Mr. Peter Dane, Senior Planner, reported to the Members of the Committee: requested to go forward for Council action on November 2, 2020; correcting safety issues at the intersection; preparing for the Marymoor light rail station; and this project is currently in the CIP.

General discussion ensued regarding contract bid amount; bike lane crossing; reconfiguring the left turn lanes; free flow right turn lane; no extension of the westbound turn lane; traffic study conducted during peak hours; discussions with other jurisdictions that will utilize light rail; funding from Sound Transit; and this item can go forward for Council action on the November 2, 2020 special meeting agenda.

10000 Avondale Final Design and Construction Consultant Agreement (*this item was removed at the time of the meeting*)

Tribal Carved Art Piece Lower Bear Creek

Mr. Tom Hardy, Senior Planner, reported to the Members of the Committee: City signed a MOU to address adverse impacts to Bear Creek; near the trail; house post from a Coast Salish House

Post; working with an archaeologist, tribes, and the Army Corp of Engineers; and an official ceremony will be held later next year.

General discussion ensued regarding budget priority and funding; posting historical information; and this item will go forward for Council action in November on the Consent agenda.

2021 Annual Indexing of Development Impact Fees

Ms. Caroline Chapman, Senior Planner, reported to the Members of the Committee: indexing of fees from new developments; methodology; changes in fees; providing a staff report at the October 20, 2020 business meeting; and pass-through impact fees for the Lake Washington School District.

General discussion ensued regarding fees in comparable jurisdictions; environmental issues; and manufacturing payment of fees.

Adoption of 2021-2026 Six-Year Transportation Improvement Program (TIP)

Ms. Tam Kutzmark, Senior Planner, reported to the Members of the Committee: a public hearing will be held on October 20, 2020 at the Council business meeting; planning document; does not obligate the City to spend money; and includes both funded and unfunded projects.

General discussion ensued regarding sidewalk repairs; projects map; and removing projects.
