

## **CALL TO ORDER AND ESTABLISHMENT OF QUORUM**

A Special Meeting of the Redmond City Council was called to order by Mayor Birney at 7:00 p.m. Council members present and establishing a quorum were: Anderson, Carson, Fields, Forsythe, Khan, Kritzer and Padhye.

The purpose of the special meeting was to review the 2021-2022 Biennial Budget and the Redmond Senior and Community Center Decision. Mayor Birney stated that Councilmember Kritzer will be chairing the 2021-2022 Biennial Budget review. Councilmember Kritzer overviewed the process for the discussion this evening.

### **1. 2021-2022 Biennial Budget Review**

Mr. Jonny Chambers, Technology and Information Services Director, and Mr. Dave Juarez provided a report to the Members of the Council: CIP and TIP Highlights.

Discussion ensued regarding projects in the CIP in the Downtown and Overlake neighborhoods.

### **2. Redmond Senior and Community Center Decision**

This item was postponed from the September 15, 2020 business meeting. The motion on the floor is:

MOTION: Councilmember Carson moved to authorize the Mayor and staff to move forward on construction of a community building at the existing site of the Redmond Senior Center in the size of approximately 42,000 square feet (and with optional expansion capabilities) at a cost not to exceed 46.7 million dollars and with the funding mechanism of Capital Improvement Program funds and councilmanic bonds. The motion was seconded by Councilmember Kritzer.

Following Councilmember remarks;

MOTION: Councilmember Anderson made a motion to amend to Authorize the Mayor and staff to repurpose the funds allocated for the Redmond Senior and Community Center in the existing 2019-2020 budget for the community involvement including seniors in

every step of the process and design of a community center located on the existing site of the Redmond Senior Center. The motion was seconded by Councilmember Fields.

Following Councilmember remarks;

MOTION: Councilmember Kritzer made a secondary motion to amend to add and design of a community center using feedback from our community stakeholders located on the existing site of the Redmond Senior Center. The motion was seconded by Councilmember Padhye.

MOTION: Councilmember Fields called the question.

VOTE: The motion to call the question passed (6-1) with Councilmember Kritzer in opposition.


VOTE: The secondary amendment failed (3-4) with Councilmembers Carson, Kritzer and Padhye in support.

VOTE: The primary amendment passed (4-3) with Councilmembers Carson, Kritzer and Padhye in opposition.

VOTE: The main motion as amended passed (7-0).

#### **ADJOURNMENT**
