III. <u>DESCRIPTION/BACKGROUND</u>

Over the past several months, the current Mayor and Councilmembers have been preparing for the transition of a new Mayor and Council. Through this process, the Council Handbook has been updated, a Mayoral Handbook has also been created, and other materials have been gathered to provide the incoming Mayor and all Councilmembers comprehensive resources about city operations and the city budget, as well as state laws that are pertinent to their roles and responsibilities.
