Budget/Funding Constraints:

The SCORE agreement reduces the number of guaranteed daily jail beds for 2021 to twelve (12), down from fifteen (15) in 2020. The costs for guaranteed general and specialized beds are the same for 2021 as in 2020; these costs are included in the additional budget details. SCORE is imposing a new booking fee of \$35, however this fee will be waived for City bookings throughout 2021.
