Approval of Sewer Service Outside City Limits for an Existing Residence on Parcel 312606-9127 for Mena Nair, OSA 20-001

OVERVIEW STATEMENT:

Staff seeks Councils approval to allow an Outside Service Area (OSA) Agreement to provide sewer service for an existing single-family home located on Parcel 312606-9127. Approval of the OSA will:

- Authorize sewer service outside the City Limits to Parcel no. 312606-9127 subject to the owner executing a Utility Extension Agreement with the City as required by Chapter 13.36 Redmond Municipal Code.
- Authorize the Mayor to sign Utility Extension Agreements for this property in a form approved by the City Attorney in accordance with Chapter 13.36 Redmond Municipal Code.
- Authorize Planning to issue a side sewer permit upon payment of all applicable fees, including the sewer stub fee assigned to this parcel.
