- a. Ordinance No. 3037: An Ordinance of the City of Redmond, Washington, Amending Redmond Municipal Code (RMC) 9.14.010, Controlled Substances, and Repealing RMC 9.14.020, Possession of Paraphernalia Prohibited, in Response to Changes in State Law

OVERVIEW STATEMENT:

On May 13, 2021, Governor Inslee signed SB 5476, addressing the *State v. Blake* decision on felony drug possession. The

bill now makes drug possession, previously a felony, a misdemeanor and changes the possession of drug paraphernalia statute. The City's current drug paraphernalia code, RMC 9.14.020, is now in conflict with state law. RCW 69.50.4011 - 69.50.4014 have not been adopted into the RMC as for local enforcement.
